This supplement (the "**Supplement**") constitutes a supplement for the purposes of Article 23(1) of Regulation (EU) 2017/1129. This Supplement is supplemental to, and should be read in conjunction with, the base prospectus prepared by Dometic Group AB (publ) (the "**Issuer**") dated 14 June 2024 (the "**Base Prospectus**") in connection with its Euro Medium Term Note Programme (the "**Programme**") for the issuance of up to €1,500,000,000 in aggregate principal amount of notes ("**Notes**"). Terms given a defined meaning in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement.

The purpose of this Supplement is to:

- (a) incorporate by reference into the Base Prospectus the unaudited interim consolidated financial statements of the Issuer in respect of the nine-months ended 30 September 2024 (the "**Unaudited 2024 Q3 Financial Statements**") as set out on pages 9–20 (inclusive) of the Issuer's Quarterly Report Q3 2024; and
- (b) update the section entitled "General Information" in the Base Prospectus.

This Supplement has been approved by the Central Bank of Ireland (the "**Central Bank**"), as competent authority under Regulation (EU) 2017/1129 (the "**EU Prospectus Regulation**"). The Central Bank only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the EU Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer nor as an endorsement of the quality of the Notes issued under the Programme that are the subject of the Base Prospectus. Investors should make their own assessment as to the suitability of investing in the Notes.
